## Job Description:

As a **Functional Safety Engineer (m/f/d)**, you are largely responsible for ensuring the functional safety of products and systems in accordance with the relevant standards such as ISO 26262 (for the automotive sector) or IEC 61508 (for other industrial applications). You will play a key role in identifying, analyzing and mitigating safety risks over the entire life cycle of a product.

- **Analysis and evaluation:** Carrying out safety analyses, such as FMEA, FTA and DFA, to identify potential risks
- **Concept development:** Creation of safety concepts (functional safety concept, technical safety concept) in accordance with applicable standards
- **Safety management:** Responsibility for creating and maintaining the safety plan and tracking all safety requirements
- **System development:** Close cooperation with system and software development in order to integrate safety requirements into the development process at an early stage
- **Testing and validation:** Performing and supporting safety verification and validation, including HIL and SIL testing
- **Standards compliance:** Ensuring that all safety
